The direct answer

Two official HSMV forms cover most vehicle-notarization needs. HSMV 82042 verifies the VIN and odometer reading (in-person only, physical inspection required). HSMV 82053 authorizes someone else to handle title transfer, registration, or pickup on the owner's behalf. EMC notarizes both using the current official form, not a third-party template.

VIN verification (HSMV 82042) — checklist

- ☐ Vehicle available for physical inspection (EMC comes to the vehicle).
- ☐ Current title or registration paperwork on hand to cross-reference the VIN.
- ☐ Government-issued photo ID for the person requesting verification.
- ☐ Confirmed with the county tax collector's office whether anything beyond the standard HSMV 82042 is needed (salvage titles sometimes require more).

Pickup / power of attorney authorization (HSMV 82053) — checklist

- ☐ Vehicle title or registration information (VIN, plate number) on hand.
- ☐ Confirmed exactly what the authorized person will do (pick up only, sign title transfer, complete registration) since wording needs may differ by tag office.
- ☐ Government-issued photo ID for the vehicle owner signing.
- ☐ If shipping out of state or internationally: confirmed whether the receiving party also needs the form apostilled (see [templates/apostille-request-kit.md](#)).

What EMC does not do

I don't determine which HSMV form fits an unusual title situation (a lien in dispute, a probate/inherited vehicle, a commercial fleet transfer); those go back to the tax collector's office or the owner's attorney.
